Directives Governing Implementation of Ph.D. Candidate Qualifying Examination, Department of Life Sciences, National Taiwan Normal University

第一條 本實施要點依據本校「學位授予暨研究生學位考試辦法」第十六條之規定訂 定。

#### Article 1

The Directives are formulated in accordance with Article 16 of the "NTNU Degree Conferral and Graduate Degree Exam Regulations".

第二條 博士生應於在學第六學期結束前,申請並進行資格考筆試。通過筆試後次一學期內,進行論文計畫書口試。

#### Article 2

Doctoral students should apply for and take the qualifying written examination before the end of their sixth semester. After passing the written examination, they will take the oral thesis examination within the following semester.

第三條 申請「資格考筆試」與「論文計書書口試」:

# (一) 資格考筆試:

#### 1. 申請:

- (1) 於每年三月三十一日或十月三十一日前提出申請,其他時間不接受申請。
- (2) 課程指導委員會依據各研究生歷年修課情況,推薦資格考筆試科目, 並填具「資格考筆試申請書」送研究生教育委員會議審議並聘任相關 教師命題。
- (3) 指導教授命題以不超過一科為原則。

# 2. 考試規則:

- (1) 考試科目為各研究生與研究相關之修習科目三科。
- (2) 考試日期由本系安排,考試時間以每科三小時為原則。
- (3) 各科成績以一百分為滿分,七十分為及格。
- (4) 不及格者,得於次一學期申請重考不及格科目,惟各科目的重考以一次提出為限,重考仍不及格者,依本校「學則」第六十條之規定,勒今退學。

### (二) 論文計畫書口試:

#### 1. 口試委員聘任:

- (1) 論文計畫書口試委員五人(含指導教授):須含三分之一校外委員,委員須為(研究員)、副教授(副研究員),由指導教授推薦後,填寫「論文計畫書口試委員推薦表」,送研究生教育委員會核備。
- (2) 非上述資格之口試委員,須具備博士學位。檢附相關佐證資料,為5年內發表2篇為第一或通訊作者的SCI論文,或具博士學位且在相關領域工作累積10年以上資歷證明,送研究生教育委員會議核備。

### 2. 考試規則:

- (1) 以各研究生提出口試當下之研究主題與進度作為口試之主要內容。
- (2) 論文計畫書應於口試前2週內送交論文計畫書口試委員。
- (3) 論文計畫書口試委員於口試完成後,判定是否通過論文計畫書口 試。
- (4) 通過論文計畫書口試者,於當學期繳交「論文計畫書口試紀錄表」 送交研究生教育委員會議核備。
- (5) 未通過論文計畫書口試者,得於次一學期重新進行口試,以一次為限,仍不通過者,依本校「學則」第六十條之規定,勒令退學。

#### Article 3

Apply for the "Qualifying Examination Written Examination" and "Thesis Proposal Oral Examination".

- 1. Qualifying Examination Written Examination:
  - (1) Application:
    - a. Applications must be submitted before March 31 or October 31 of each year. Applications will not be accepted at other times.
    - b. The Curriculum Steering Committee will recommend courses for the Qualifying Examination based on the graduate students' past course attendance. The committee will complete the "Doctorate Candidate Qualifying Examination Application Form" and submit it to the Graduate Education Committee for review and appointment of relevant teachers to set the examination questions.
    - c. The advisor should not set questions for more than one subject.

# (2) Examination Rules:

- a. The examination subjects are three subjects related to research taken by each graduate student.
- b. The examination date will be arranged by the department. The examination time is three hours per subject.
- c. The full score for each subject is 100, and 70 is the passing score.
- d. Students who fail the course may apply to retake the failed course in the following semester. However, they may only apply once for retaking each

course. Students who fail the course again will be expelled from the school in accordance with Article 60 of the Academic Regulations.

## 2. Thesis Proposal Oral Examination:

- (1) Appointment of oral examination committee members:
  - a. Five members (including advisor) shall be members of the oral examination committee for the thesis proposal: one-third of the members shall be external members. The members shall be (researchers) or associate professors (associate researchers). After being recommended by the supervising professor, they shall fill out the "Recommendation Form for Oral Examination Committee of Thesis Proposal" and submit it to the Graduate Education Committee for approval.
  - b. Oral examiners who are not qualified as mentioned above must hold a doctoral degree. Attach supporting documents, including two SCI papers published within the past five years as the first or corresponding author, or proof of a doctoral degree and more than ten years of experience in related fields, to the Graduate Education Committee for approval.

### (2) Examination Rules:

- a. The main content of the oral interview is the research topic and progress of each graduate student.
- b. The thesis proposal should be submitted to the oral examination committee within 2 weeks before the oral examination.
- c. After the oral examination, the oral examination committee will determine whether the candidate has passed the oral examination.
- d. Applicants who pass the oral examination for the thesis proposal should submit the "Doctoral Thesis Proposal Oral Presentation Record Form" to the Graduate Education Committee for approval in the current semester.
- e. Students who fail the oral examination for the thesis proposal may retake the oral examination once in the following semester. If they still fail, they will be expelled in accordance with Article 60 of the Academic Regulations of the University.

第四條 本實施要點未盡事宜,悉依本系碩、博士班修業暨研究生學位考試規定等相關 規定辦理。

#### Article 4

Any matters not covered in these implementation points shall be handled in accordance with the relevant regulations of the department, including the regulations on the completion of master's and doctoral programs and the postgraduate degree examination.

第五條 本實施要點經生命科學專業學院院務會議通過,並送教務處核備後實施,修訂 時亦同。

# Article 5

These implementation points have been approved by the Faculty of Life Sciences at their administrative meeting and submitted to the Academic Affairs Office for approval before implementation. The same applies to revisions.
